**A BILL**

To provide that no Federal funds may be used to carry out the proposed rule of the Department of Homeland Security entitled “Inadmissibility on Public Charge Grounds”, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “No Federal Funds for  
5       Public Charge Act of 2018”.

6       **SEC. 2. SENSE OF CONGRESS.**

7       It is the sense of Congress that—

1           (1) immigrants and their families are a core  
2 part of our nation;

3           (2) their health and safety is critical to the  
4 health and safety of our communities.

5           (3) Federal, State, and local assistance pro-  
6 grams promote self-sufficiency by ensuring that fam-  
7 ilies, including immigrant and mixed-status families,  
8 maintain their health, strength, and stability, and  
9 can continue contributing to the nation’s social and  
10 economic life;

11          (4) the proposed rule of the Department of  
12 Homeland Security entitled “Inadmissibility on Pub-  
13 lic Charge Grounds” is a sweeping and dangerous  
14 proposal that will impede access to essential food,  
15 medical care, and housing for many families;

16          (5) the proposed rule would damage State and  
17 local economies while burdening health and service  
18 providers, and the Department of Homeland Secu-  
19 rity itself, in the preamble of the proposed rule, ac-  
20 knowledges the severe consequences of this proposal  
21 including that it could cause “worse health out-  
22 comes, including increased prevalence of obesity and  
23 malnutrition, especially for pregnant or  
24 breastfeeding women, infants, or children,” that it  
25 may “decrease disposable income and increase the

1 poverty of certain families and children, including  
2 U.S. citizen children” and that it could lead to “re-  
3 duced revenues for healthcare providers,” “phar-  
4 macies,” “companies that manufacture medical sup-  
5 plies or pharmaceuticals,” “grocery retailers,” and  
6 “agricultural producers”; and

7 (6) the proposed rule would circumvent Con-  
8 gress and reverse 100 years of law and policy, re-  
9 stricting immigration and chilling access to services  
10 for which immigrants and their citizen family mem-  
11 bers are eligible, in a manner not authorized or con-  
12 templated by Congress.

13 **SEC. 3. RESTRICTION ON FEDERAL FUNDS.**

14 No Federal funds (including fees) made available for  
15 any fiscal year, may be used to implement, administer, en-  
16 force, or carry out the proposed rule of the Department  
17 of Homeland Security entitled “Inadmissibility on Public  
18 Charge Grounds”.
