**A BILL**

To amend section 477 of the Social Security Act to increase the maximum education and training voucher amount and provide greater support for foster youth pursuing postsecondary education.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Foster Youth Postsec-  
5 ondary Education Access and Success Act”.

1 **SEC. 2. INCREASE IN MAXIMUM EDUCATION AND TRAINING**  
2 **VOUCHER AMOUNT AND PROVISION OF**  
3 **GREATER SUPPORT FOR FOSTER YOUTH**  
4 **PURSUING POSTSECONDARY EDUCATION.**

5 (a) IN GENERAL.—Section 477(i) of the Social Secu-  
6 rity Act (42 U.S.C. 677(i)) is amended—

7 (1) in paragraph (3)—

8 (A) by striking “training program” and in-  
9 serting “training program (except that the  
10 State may establish a grace period to allow a  
11 youth to continue participation in activities de-  
12 scribed in subsection (i)(4)(A), after an assess-  
13 ment and consultation with the youth, if the  
14 State determines that reasonable circumstances  
15 warrant the grace period),”;

16 (B) by striking “that program” and insert-  
17 ing “that education or training program”; and

18 (C) by striking “the program” and insert-  
19 ing “the voucher program”; and

20 (2) in paragraph (4)(B), by striking “\$5,000”  
21 and inserting “\$12,000”.

22 (b) GUIDANCE.—The Secretary of Health and  
23 Human Services, in consultation with youth who have ex-  
24 perience foster care, shall develop and issue model guid-  
25 ance to States and jurisdictions receiving allotments under  
26 section 477(c) of the Social Security Act for implementa-

1 tion of the amendment made by subsection (a)(1) of this  
2 section.

3 **SEC. 3. IMPROVING ACCESSIBILITY AND YOUTH AWARE-**  
4 **NESS OF EDUCATION AND TRAINING VOUCH-**  
5 **ERS.**

6 (a) IN GENERAL.—Section 477(i) of the Social Secu-  
7 rity Act (42 U.S.C. 677(i)) is amended by adding at the  
8 end the following:

9 “(7) The State shall make reasonable efforts to  
10 ensure that eligible youth are aware of potential ben-  
11 efits provided under this subsection, including by co-  
12 ordinating with programs funded under subsection  
13 (h)(1).

14 “(8) The program shall include a simplified,  
15 user-tested, and standard form for youth to use to  
16 apply for vouchers under the program, using stand-  
17 ard terminology, that is easily accessible and avail-  
18 able electronically.”.

19 (b) USE OF FUNDS.—Section 477(d)(1) of such Act  
20 (42 U.S.C. 677(d)(1)) is amended to read as follows:

21 “(1) IN GENERAL.—A State to which an  
22 amount is paid from its allotment under subsection  
23 (c)(1) may use the amount in any manner that is  
24 reasonably calculated to accomplish the purposes of  
25 this section, including outreach related to subsection

1 (i)(7). A State to which an amount is paid from its  
2 allotment under subsection (c)(3) may use the  
3 amount for any purpose related to the program de-  
4 scribed in subsection (i)(7).”.

5 **SEC. 4. EFFECTIVE DATE.**

6 The amendments made by this Act shall take effect  
7 on the date that is 1 year after the date of the enactment  
8 of this Act.
